When digital mode is active on the repeater, you will hear digital noise when using an analog radio unless you have the digital tone squelch 532 programmed into your radio for receive.

This is a directed NET. Please direct all traffic through NET Control. This is also an open NET, and we encourage all listening to participate by checking in. You will need an amateur radio license class of Technician or higher. I will now stand by for any station having emergency or priority traffic. Any stations with such traffic ONLY please call now.
